At the February 26, 2024, meeting, we discussed ways to get input about CDPH services from people currently served. We asked about current participant surveys.

- Prior to 2012, CDPH collected and reported on mental health center participant surveys.
- CDPH used to employ a [peer] program coordinator to facilitate survey collection.
- CDPH surveyed participants in 2018, but a tally or analysis, if done, was not made available.
- In 2019 and 2020, CDPH was asked about the status of center participant surveys. Here is a link to the CDPH 2020 Consumer Survey form: consumer survey final 2020.pdf
- When COVID moved most CDPH mental health services to telephone and videoconferencing, we asked whether participants were surveyed about access to the internet as well as consumer visit preferences.
